The article addresses the extent of Prosecutorial Misconduct in Orange County stating that "Prosecutorial cheating apparently extends to relatively minor trials, too.", which Mr. Iocona exposed in 2015 during the trial of The People of the State of California vs. Sandra Goelman.

In 2015, Mr. Iocona was also selected as a "Superior DUI Attorney" by The National Advocacy for DUI Defense (NAFDD). That same year, he was also selected for inclusion in the 2015 list of the "Nation's Top One Percent", which is published by the National Association of Distinguished Counsel (NADC).
